- Dollar Tree – 138 Pine Plaza, Silsbee - Earned a score of 98. No thermometers observed in reach in coolers.
- Dollar Tree –725 N Main St, Lumberton – Earned a score of 98

- Tobacco Barn #89 – 425 S Main St, Lumberton – All specifications met – Earned a score of 100.
- Family Dollar #12439 – 1235 Hwy 327, Silsbee – All specifications met – Earned a score of 100.
- Family Dollar #S7906 -840 S Pine St, Kountze – All specifications met – Earned a score of 100.
- Tobacco Barn #459 – 285 Hwy 105, Sour Lake – All specifications met – Earned a score of 100.
- 10 De Mayo Mexican Grill & Bar – 467 N LHS Dr, Lumberton –
linens covering chicken & beef observed unclean, multiple raw & prepared foods held in the walk in cooler had no date markings to indicate the date the foods shall be consumed or discarded, chicken observed stored pooling in direct contact with a bowl of water, in-use utensil was placed on an unclean surface, scoops for dispensing flour, sugar, rice were laying in the foods & containers of foods had no name label of the product enclosed, drain tube from ice bin did not drain correctly and was draining on the floor,

dumpster doors were not in a closed position & lid covering was missing - earned a score of 91

- 409 Nutrition – 214 N Main St, Lumberton – All specifications met – Earned a score of 100.
- Walgreens – 902 N Main St, Lumberton – All specifications met – Earned a score of 100.
- Shell Fast Lane #1 –901 N Main St, Lumberton – ice shoot on the soda machine was observed with a buildup of grim – earned a score of 97
- Triple A Seafood –110 N Main St, Lumberton – All specifications met – Earned a score of 100.
- Dollar General – 319 N Main, Lumberton – thermometers were not observed in the reach in coolers – earned a score of 98
- Dollar General (LHS) –463 N LHS Dr, Lumberton – thermometers not observed in the coolers - earned a score of 98
- MNS Nutrition –837 N Main, Lumberton – a carton of shell eggs & cream cheese observed in the reach in cooler exceeded their use by date, a person in charge holding a food manager certification was not on duty, other employee food training certifications were not on site for verification, most recent health inspection was not on display for customer view, earned a score of 94
- Good Grounds Coffee & Café – 769 S Main St, Suite D, Lumberton – all specifications were met - earned a perfect score of 100
- Daily Cream Donuts – 42494 Hwy 105, Batson - all specifications were met - earned a perfect score of 100
- Dollar General #18041 — 42685 Hwy 105, Batson All specifications met – Earned a score of 100.

- Super Pak Deli – 16618 FM 770, Saratoga – spray bottle containing a cleaning substance had no name labeling, observed containers of foods at the pizza prep station being refilled – not being replaced with new containers of food when empty, an overall cleaning of the facility from floor to ceiling was needed and continued as often to keep clean – earned a score of 94
- CVS #2996 – 100 S LHS Dr., Lumberton - All specifications met – Earned a score of 100.
- Southern Mess Nutrition – Sour Lake – All specifications met – Earned a score of 100.
- Dollar General – 575 Hwy 105 W, Sour Lake – thermometers not observed in the reach in coolers – earned a score of 98
- Dollar Tree – 360 Hwy 105 E, Sour Lake - All specifications met – Earned a score of 100.
- Dollar General #15810 – 1611 FM 3513, Lumberton - All specifications met – Earned a score of 100.
- Donut Palace – 555 Hwy 69 S Pine St, Kountze – kolaches, bacon/sausage & egg sandwiches in the front display case for sale were not marked with 4 hours past the time the foods were removed from temperature control, packages of lunch meat ham & salad dressings exceeded the manufacture use by date, the opened package of ham was not in a closed container or dated after opening – earned a score of 95
- Captain Bob's Galley – 12309 FM 92, Silsbee - All specifications met – Earned a score of 100.
- Hwy 105 Food Mart – 690 Hwy 105 W, Sour Lake – soda machine & large ice machine were observed with a black grim substance, observed employee putting on clean gloves with no hand washing before-hand, foods in the prep cooler exceeded manufacture use by date, cut foods in packages did not bear discard date labeling,

observed no hot water @ the hand sink in the restroom, floor cleaning equipment was stored touching stored foods on shelving, flour, spices removed from their original packaging & stored in large containers were not name labeled, an overall cleaning of ventilation baffles and all equipment was needed, personal foods were not segregated in walk in cooler & labeled employee foods, most recent health inspection was not on display for customer view - earned a score of 85

- Circle K – Lumberton (New Ownership) – 501 S Main St, Lumberton - All specifications met – Earned a score of 100.
- Dunkin Donuts – 112 S. Main St, Lumberton - Earned a score of 94
Observed employee placing gloves on before washing their hands before handling foods, sugar taken from original packaging & placed in a large bin had no name labeling, counters & hand sink areas were observed not clean & sanitized daily, an overall cleaning was needed
- Fuel Max #73 – 15724FM 421, Kountze – - Earned a score of 83 -
Employee preparing and serving the foods on duty did not hold a food manager certification, other employees did not hold a food handler certification, meat pies, a pot of cooked beef had no 4 hour discard time after being taken from cooking temperature, observed a large pot of cooked cut vegetables & spices that had been in refrigeration the day before now placed in prep sink – no monitoring of time was observed, no hot or cold hold thermometers were observed, no soap at the 2 hand sinks provided, employee observed putting on gloves before washing hands, most recent health inspection was not on display for public view
- Fuel Max #70 – 15800 Hwy 105, Sour Lake- Earned a score of 93

– Staff did not hold or able to present food handler certification on site during the inspection, maseca was taken from original packaging & placed in large container not bearing the name of product, scoops for dispensing the food was laying in the food, scoops with a handle are required in the upright position, thermometers were not observed in the coolers or the cold hold equipment, cold hold equipment on the prep line was not in good repair- not allowing water to hold, walk in freezer had large amounts of frozen ice accumulation on the ceiling & on the freezer floor

- Schlotzskys Deli - 295 Country Lane, Lumberton – Earned a score of 97 – Observed clean in place equipment with food and grime that needs to be cleaned. Microwave was dirty.
- Domino's - 1330 N. 5th Street, Silsbee – Earned a score of 98 – Observed rolling cart with food accumulation. Wet wiping cloth was observed hanging on faucet of hand sink.
- Domino's - 191 S LHS Dr., Lumberton – Earned a score of 99 - Observed wet wiping cloth on prep table.
- Boutte's Boudin - 568 North LHS Dr., Lumberton – Earned a score of 100.
- Waffle House - 750 South Main, Lumberton – Earned a score of 100.
- Liberty Tree Coffee - 115 W. Hwy. 105, Sour Lake – Earned a score of 99 - Employees observed with no hat or hairnet.
- G Taco House - 115 Hwy 105 West, Sour Lake – Earned a score of 100.
- Goodfella's Pizza - 785 West Hwy 105, Sour Lake – Earned a score of 100.
- Courthouse Café – 300 West Monroe, Kountze – Earned a score of 100.

- Hot Wok - 76 N LHS, Lumberton – Earned a score of 77 – Observed dirty lids holding TCS foods. No sanitizer being used. No clean contact surfaces. Observed employee changing tasks without washing hands. No Certified Food Manager on duty. No Food Handler for staff. No label or dates on food in walk in cooler. Found mouse droppings in cardboard boxes. No lids on containers holding flour and sugar. Single-use utensil’s being stored in cardboard box with no protective packaging. Establishment needs to be cleaned. Lights in kitchen were out. Lid was open on outside receptacle.
- Sno Barn - 42739 Hwy 105, Batson – Earned a score of 100.
- Village Creek Rehabilitation - 705 North Main, Lumberton – Earned a score of 96 – Ice machine needs to be cleaned. Tile needs to be repaired by warewash.
- Paradigm at the Pines - 705 FM 418 West, Silsbee – Earned a score of 95 - Spaghetti temped at 120 in hot hold. Employee took off and reheated in microwave. Beef had a date past 7 days. Discarded.
- Rikenjaks - 358 North LHS Drive, Lumberton – No sanitizer buckets made. No thermometer in reach in cooler.
- Spanish Trail Assisted Living - 775 Hwy 96 S., Silsbee – Earned a score of 100.
- Paradigm at Kountze - 604 FM Rd. 1293, Kountze – Earned a score of 96 – Can opener needs to be cleaned. Air vents need to be cleaned.
