



July 2026 – Hardin County Health Inspections

PJ's Country Store – 6630 FM 92, Silsbee - Earned a Score of 98 — Items in the freezer were removed from its original packaging, but had no dates or labels.

Exxpress Mart #24 – 3025 HWY 96 Bypass, Silsbee – Earned a score of 86 – Sausage roller conveyor was observed dirty and wasn't in use. No air gap on soda dispenser drain. Observed food items past discard date. Wall juncture needs to be repaired. Growing black mold substance. Drink dispenser tray had buildup of black mold substance.

Champion Ranch – 6200 Country Club Rd, Silsbee – Earned a score of 91 – Reach in cooler was temped at 47. Microwave was observed soiled. Observed food package that had been chewed through from pest. Observed pest droppings. Observed holes from outside of building that need to be covered and repaired. Shelves in storage area were observed contaminated. Mops were observed laying in utility sink.

Fuel Maxx #89 – 13910 Hwy 69 N., Village Mills – Earned a score of 95 - Observed sandwich and other food that was outdated in walk in cooler. No Certified Food Manager on duty.

Walmart – 1100 Hwy 96 North, Silsbee – Earned a score of 96 – Deli meat was observed past discard date. No paper towels at produce hand sink.

Tejas #8 – 2142 Hwy 327, Silsbee – Earned a score of 98 – Hand sink was not accessible. No paper towels at hand sink.

Light Of Mine – 9163 1st. St., Batson – Earned a score of 100.

Younger Years – 615 Creekmore, Silsbee – Earned a score of 100.

Younger Years – 719 S. Main St., Lumberton – Earned a score of 100.

Silsbee Sips – 275 hwy. 96 South, Silsbee – Earned a score of 100.

J R Food Mart – 1240 North 5th St., Silsbee – Earned a score of 82 – Walk in cooler was temped at 50F. No sanitizer being used. Observed food past discard date. Observed employee put on gloves without washing hands. No dates on chicken. No hand soap at

hand sink. Hand sink was not accessible. Personal items on prep table. Fish was being improperly thawed.

Tejas #4 – 770 South Pine, Kountze – Earned a score of 100.

Tejas #5 – 3322 FM 92, Silsbee – Earned a score of 97 - Nozzles on beverage dispensers had black substance inside.

Hwy 96 Truckstop – 5008 Hwy 96, Silsbee – Earned a score of 90 - Observed eggs sitting out at a temp of 70F. Drink dispenser nozzles were observed with black substance. Food was observed past discard date. No soap at hand sink.

Ro's Seafood – 118 N Main, Lumberton – Earned a score of 74 – Oysters were observed sitting on counter and was temped at 57F. Spring rolls were made at home and brought to establishment. Shrimp was being thawed improperly. No sanitizer was being used. Chemical spray bottle had no label. No Certified Food Manager on duty. No food handlers on duty. No dates or label on food s in walk in cooler. Multiple wet rags on prep counter. Foods stored in walk in cooler had no covers or lids. Cardboard boxes being used in establishment for prepping food on.

EZ Mart #2 – 210 Hwy 96 S., Silsbee – Earned a score of 82 – Reach in cooler was temped at 45F. No time on was observed on chicken wings. Drink dispenser nozzles observed with black substance. No Certified Food Manager on duty. No dates on food in cooler. No paper towels at hand sink. Pizza cutters were observed in not good condition. Walls and floors were observed soiled. Bathroom was observed with contamination.

Eddie's Gyro's N Pizza – 441 S. Main, Lumberton – Earned a score of 98 – Walk in cooler was temped at 50F.

Tia Junaita's – 322 S. Main, Lumberton – Earned a score of 85 – Cross contamination with ready to eat food and raw items. Observed employee not wash hands before putting on gloves. Hand sink was observed with items inside of it. Multiple wet rags on prep counters. Observed shrimp being thawed improperly. No labels on bulk items. Walls and ceilings observed soiled. Receptacle missing both lids outside.

Happy Donuts – 104 S LHS Dr., Lumberton – Earned a score of 92 – Eggs temped at 74F. Hand sink was not accessible. Wet rag on prep counter.

Southern Maid Donuts – 434 N LHS Dr., Lumberton – Earned a score of 86 – Cold hold items temped at 49F. No time on kolaches and sausage biscuits. Medicines being stored on shelf with food. No dates on food in reach in cooler. No sanitizer being used.

Domino's – 1330 N. 5th St., Silsbee – Earned a score of 77 – Prep cooler was temped at 53F. No sanitizer being used. No hot water. Rolling cart was observed with food soil. Woman's restroom observed soiled.

Domino's – 191 S LHS Dr., Lumberton – Earned a score of 100.

Dunkin Donuts/Baskin Robbins – 112 S. Main, Lumberton – Earned a score of 91 – Lids to ice cream tubs were observed with condensation that had leaked into the ice cream. Food product in boxes were observed sitting on floor where it was wet. Observed employee put on gloves without washing hands first.

Children's World – 130 East Cora Lee St., Sour Lake – Earned a score of 98 - Microwave was observed with rust on inside. Cabinets were observed to have dirt on contact paper and contact paper was coming up.

Subway – 565 Hwy 105 West, Sour Lake – Earned a score of 97 – Observed employee put on gloves without washing hands.

Hwy 105 Food Mart – 690 Hwy 105 West, Sour Lake – Chemicals being stored near single use items. Drink dispenser nozzle and equipment observed with black substance.

Sno Barn – 42739 Hwy 105, Batson – Earned a score of 100.

Tobacco Barn #36 – 809 Hwy 69 S., Kountze – Earned a score of 99 – Ceiling tiles need to be repaired and replaced.

Fill Your Cup - 1440 South Pine St., Kountze – Earned a score of 95 – Observed employee perform multiple tasks without washing hands. Hand sink being used for storage.

Phil's on the Hill – 4444 HWY 327, Kountze - Earned a score of 100.

Subway – 760 HWY 96 S. Silsbee - Earned a score of 97. The ice machine was red tagged due to a presence of a slimy black substance. Equipment was descaled, cleaned, and sanitized and the red tag was removed within the same day.

Popeyes – 108 S. LHS Drive, Lumberton - Earned a score of 100.

Tiger Hut – 112 Pine Plaza, Silsbee - Earned a score of 96. The left side of the cold hold equipment temped at 53 and the right side temped at 51. Multiple ceiling tiles need to be replaced so that no gaps are showing. Observed one live roach and multiple dead roaches during inspection. The establishment is aware of the issue and has already had pest control treatment services twice to resolve this matter.

Chili's Bar and Grill - 1010 Hwy 96 South, Silsbee - Earned a score of 100.

Novrozsky's – 1170 Hwy 327 East, Silsbee - Earned a score of 92. The ice machine was observed to have a build up of black residue. Multiple containers in the reach-in freezers and coolers did not have any labels or dates. Single-use containers were being used as a scoop in multiple locations. Observed a build up of dust on the air vents, and there was no cover on the trash can in the ladies' room.

Potbelly Sandwich Shop – 309 North LHS Drive, Lumberton - Earned a score of 99. Observed multiple buckets of pickles and a bag of onions on the floor of the walk-in freezer.

Firehouse Subs – 301 North LHS Drive Suite 100, Lumberton - Earned a score of 99. Wet rags were observed on countertops in working areas.

Wendy's – 518 South Main, Lumberton - Earned a score of 96. One employee's food handler certificate was expired. Observed a buildup of condensation on the vent hoods, and the mirror/walls in the girls' bathroom were foggy. Observed significant damage to the ceiling in the women's bathroom, and there was a presence of an unknown black substance on the walls.

Mr. Burger & Seafood – 205 Hwy 96 South, Silsbee - Earned a score of 92. No sanitizer bucket was present at the time of inspection. Items in the freezers and coolers had no labels or dates. Observed a scoop improperly stored in a working container. The hot water valve in the restroom was found broken with no access to hot water in this bathroom.

McDonalds – 103 North Main, Lumberton - Earned a score of 99. Observed no lid on the trashcan in the ladies' restroom.

Exxpress Mart #12 – 196 South LHS Drive, Lumberton - Earned a score of 100.

Papa John's Pizza – 209 South Main, Lumberton - Earned a score of 98. Observed personal items being stored in the walk-in cooler and utensils on the prep line were improperly stored.

The Toasted Yolk – 900 South Main Street, Lumberton - Earned a score of 93. Observed personal items being stored with establishment items, no labels or dates on merchandise in the walk-ins, one handwashing sink did not have hot water, and a different handwashing sink did not have hand soap.

Chicken Express – 520 South Main Street, Lumberton - Earned a score of 94. Observed items in the walk-ins with no labels, wet cloths were left on the counter in multiple

locations, utensils improperly stored in multiple working containers, a missing ceiling tile with exposed cords, and the trashcan in the ladies' room did not have a proper cover.
